- Spring Sports Dates – concussion (Feb 26), 1<sup>st</sup> tryout (Feb 28), parents meeting (Mar 10), team photos (Mar 26)

## **COMMITTEE UPDATES:**

### **Community Relations:**

- Tammy and Bryan will continue to pursue brackets for gym advertisements. A permit will be needed to install.
- Dickie's Barbeque Pit is waiting until next season to consider a sponsorship.
- Premier Driving School – need to meet with them
- Remax another possible sponsor

### **Merchandising:**

- Finished deliveries for end of year. Needed to order additional sweatshirts to fill orders.
- Selling Loud and Proud shirts for \$12.00 at home games.

### **Concessions:**

- Have hosted several basketball games. Turnout low for wrestling match – will only open for tournament meets
- Cheer competition and JV wrestling tournament – will sell Chick-fil-A for both and use community room.

### **Membership:**

- Currently have 129 members – winter memberships have slowed
- Incentive deliveries are up to date
